The funds are not given directly to the student but are paid directly to the teacher so the organization is certain of the use of the funds. The teacher provides the organization with monthly reports on the child's progress.

Tuition assistance is offered to teachers who meet certain eligibility requirements.

Eligibility requirements vary depending on the restrictions of the donor and the class.
